Company and Customer also may be individually referred to herein as "Party." Collectively referred to herein as the "Parties."

- Dumpster Rental- Customer agrees to rent a dumpster from Company per the attached rental schedule below, or located on convenientcan.com for \_\_\_\_\_ days at \$ \_\_\_\_\_. **Customer is to provide 48 hours advance pickup notice submitted to info@convenientcan.com.** If no notice is provided, customer will be charged the next rate according to Convenient Can Rental Schedule. If 1 month of rental time is exceeded, customer agrees to pay \$10 per additional day.

- Payment- Payment is due following delivery of dumpster. Company will submit invoice with link for secure credit card payment. Payment can also be accepted through PayPal. Please inquire for more detail. If customer would prefer to pay by check or cash, payment must be received within 3 business days after delivery. Please mail to 4301 SW 29<sup>th</sup> St OKC, OK 73119. If no form of payment is received before pickup, customer will be charged a late fee of **\$35** and dumpster will not be picked up until payment clears. Customer will also be charged the next rate per the Convenient Can Rental Schedule. Bounced checks or disputed credit card transactions will also incur a penalty fee of **\$75** and customer grants full rights for company to lien billing or delivery address property. If said lien or judgment is filed against property or customer, customer will be responsible for all legal fees associated with pursuant claim of payment to company.

- Tonnage and Overfill Limits- Customer agrees not to exceed 3.5 tons of waste (6,500lbs). Overweight and overfilled containers are susceptible to additional charges. Customer hereby agrees to pay an additional charge of **\$90 per ton** and a **minimum of \$75 for dumpsters filled over sidewall.** Customer will make best efforts to evenly distribute waste in the dumpster and keep items below or at a maximum of flush with the top of dumpster. Penalties will apply for breach of this requirement and are up to the discretion of company to cover costs associated with unloading.

- Location of Dumpster and Pickup- Customer warrants and represents that any location provided by Customer for the dumpster is sufficient to bear the weight of the dumpster and any vehicle required to transport the dumpster. Company shall not be responsible for any damage to pavement or any other road surface material, lawns, fences, shrubbery, septic system, sprinkler systems, or private wells in any form or capacity whether cosmetic or structural. Customer agrees to provide unobstructed access to the dumpster. If the dumpster is inaccessible, Customer agrees to pay **\$100 trip charge** for wasted trip on pickup as well as next rate per the Convenient Can Rental Schedule attached below. Company needs 55' unimpeded access for pickup or delivery in front of dumpster.

- Non-Approved Material- Customer agrees to abide by Federal and State Laws/Regulations regarding hazardous waste and materials disposal. Specifically, dumpsters **cannot contain any of the following items: adhesives, asbestos, batteries, contaminated soils, food waste (unsecured), fuel, industrial drums, infectious waste (bandages/needles), mercury, oils, paints/lacquers, railroad ties, refrigerators and air conditioners (if not properly drained \$50 for draining appliances), tires, hot water tanks.** Contracted customer is responsible for all materials in dumpster through the rental cycle and acknowledges that materials found in dumpster that do not comply with approved disposable materials will incur additional fees at customers expense. There will be no exceptions to material violations whether customers doing or a separate 3<sup>rd</sup> party. Listed items can be disposed of, but must be handled separately and on case by case scenario, so that banned items end up at proper disposal facility, not landfill. Please inquire for more detail.

- Permits, Approvals and Fees- Customer shall be responsible for obtaining all permits and approvals necessary with their local municipalities for the delivery of their dumpster.
